CERTIFICATE OF AMENDMENT

We, the undersigned, hereby certify:

- 1. That we are the duly appointed and acting President and Secretary of Vista Redonda Mutual Domestic Water Consumers
 Association.
- 2. That the Resolution hereinafter set forth was adopted by a unanimous vote of the Board of Directors of the Corporation:

"RESOLVED, that the Articles of Incorporation of Vista Redonda Mutual Domestic Water Consumers Association shall be, and the same hereby are, amended as follows:

- 1. Article III is amended by striking the words "233 Johnson Street, Santa Fe, New Mexico," and by adding the words "Route 4, Box 58D, Vista Redonda, Tesuque, New Mexico".
- 2. Article IV (a) is amended by striking all of the words in said paragraph and by adding in its place "(a) To associate its members together on a non-profit basis for their mutual interest and benefit and to that end, to acquire, construct, install, maintain, drill wells for, and operate a water system for the supplying and distribution of water for domestic uses and purposes to its members and to do all things necessary for the operation of a complete domestic water supply and distribution system for the mutual benefit of its members."
- 3. Article IV is amended by adding a paragraph to provide: "(h) No part of the income or profit of this Association is distributable to its members, directors or officers.
